_____ I understand that this Season Pass purchase is nonrefundable for any reason.

_____ The Season Pass purchased is for the personal use only of the person whose photo and name appears on the Season Pass. I agree that the Season Pass will not be sold, given, loaned, traded or assigned to another person, or reproduced in any way whatsoever. The use or attempted use of a pass by someone other than the pass holder themselves is theft of service, and will be handled accordingly. I acknowledge that the Season Pass is, and shall remain the property of Massanutten. Upon violation of the above, my Season Pass will be revoked without a refund.

_____ I agree (1) to visibly display the Season Pass at all times; (2) to present the Season Pass to any authorized representative or management upon request; (3) to know and follow "Your Responsibility Code", and (4) to refrain from misconduct or reckless skiing/riding, acknowledging that the Season Pass may be revoked without refund. I understand I am purchasing/using the privilege (not the right) to ski/snowboard at Massanutten and this privilege may be withdrawn in Massanutten's sole discretion.

_____ I must have my Pass with me to be entitled to use the lifts and ski/snowboard at Massanutten. I understand that Massanutten will issue only (1) ONE complimentary lift ticket if I forget my pass. This ticket is for the pass holder's use only. If the pass is forgotten a second time, I will purchase a lift ticket before accessing the lifts. I further understand that the reported forgotten pass will be listed as lost for the day that the complimentary ticket is issued, and reported if used. This policy may be changed or revoked at any time.

_____ Should I lose my Season Pass I will notify the Ski Office immediately. I will be able to replace it only one-time, and will be charged a replacement fee of \$20. This charge is non-refundable. If I lose my replacement pass, I will have to buy a new pass at the original purchase price.

_____ Massanutten does not guarantee the pass holder the opening and closing dates of the 2019/2020 winter season, nor a continuous daily operation of all its lifts throughout the season. Season Pass expires at the end of the 2019/2020 ski season.

I request Great Eastern Resort Management Inc. issue a season skiing/snowboarding pass to me.

Skiing/snowboarding is an inherently dangerous sport which can result in personal injury, death, or property damage. Observe "Your Responsibility Code" at all times. If you are not willing to accept the above statement, you do not have permission to ski/snowboard this area.

YOUR RESPONSIBILITY CODE"

Skiing and snowboarding can be enjoyed in many ways. At ski areas you may see people using alpine, snowboard, telemark, cross-country, or other specialized ski equipment, such as that used by disabled or other skiers. Regardless of how you decide to enjoy the slopes, always show courtesy to others and be aware that there are elements of risk in skiing that common sense and personal awareness can help reduce. Observe the code listed below and share with other skiers the responsibility for a great skiing experience.

1. Always stay in control, and be able to stop or avoid other people and objects.
2. People ahead of you have the right of way. It is your responsibility to avoid them.
3. You must not stop where you obstruct a trail, or are not visible from above.
4. Whenever starting downhill or merging into a trail, look uphill and yield to others.
5. Always use devices to help prevent runaway equipment.
6. Observe all posted signs and warnings. Keep off closed trails and out of closed areas.
7. Prior to using any lift, you must have the knowledge and ability to load, ride, and unload safely.

KNOW THE CODE. IT'S YOUR RESPONSIBILITY.

Massanutten does not permit riding lifts, skiing, snowboarding, or snow tubing with child carriers of any kind. All ski and snowboard equipment must have metal edges.

WARNING: Under Virginia law, a ski area operator or other winter sports area operator is not liable for an injury to or death of a winter sports participant in a winter sport conducted at this location, or for damage to property, if such injury, death, or damage results from the inherent risks of the winter sport or from the participant's own negligence. The inherent risks of a winter sport include, among others, risks associated with the land, equipment, other participants, and animals, as well as the potential for you or another participant to act in a negligent manner that may contribute to the injury, death, or damage. You are assuming the inherent risks of participating in a winter sport at this location. I agree that any legal dispute arising out of this agreement, my use of the equipment, or my participation in the sport shall be submitted to mediation prior to filing a lawsuit. Only after mediation has been conducted may a lawsuit then be filed. Any such lawsuit shall be filed in the U.S. District Court for the Western District of Virginia or the Circuit Court of Rockingham County, Virginia, even if another venue is more convenient. I agree that if any portion of this Agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

I have read and understand Great Eastern Resort Management, Inc.'s rules, policies, and regulations and "Your Responsibility Code". I agree to abide by them. G.E.R.M. has the right to revoke my pass for any violation of them. I have read this document.
